

**CORONA – WIN A TRAVEL VOUCHER TO THE VALUE OF R70 000 FOR A TRIP TO A BEACH
DESTINATION
PROMOTIONAL COMPETITION RULES**

1. This promotional competition (“Competition”) is run by The South African Breweries (Proprietary) Limited (“Promoter”), and is open to all persons of 18 years or older, resident in South Africa, except the employees, of Promoter, and their immediate families, Promoter advertising and promotion agencies and associated companies.
2. The Promoter reserves the right to alter, amend or cancel this Competition in part or in its entirety (including, but not limited to, value and/or prize, bookings of the trip and/or planned activities).
3. In the event of an amendment, alteration and/or cancellation, all participants agree to waive any rights that they have in respect of this promotional competition, acknowledge that they will have no recourse against the Promoter, Shoprite Checkers (Pty) Ltd or their agents and neither the Promoter nor Shoprite Checkers (Pty) Ltd will not compensate any individual for any reason whatsoever.
4. These Competition rules and any amendments thereto, will be interpreted by the Promoter only.
5. Participation by all entrants (“Participants”) constitutes acceptance of these Competition rules.
6. The Competition starts on 22 October 2018 and ends on 9 December 2018 (“Competition Period”).
7. Entry:
 - 7.1 To enter, Participants must purchase a six-pack NRB, 12 pack NRB or case of 355ml Corona from any Checkers LiquorShop outlet in South Africa during the Competition Period and follow the instructions on the till slip to enter via USSD. USSD cost 20c per 20 seconds.
8. The Prize:
 - 8.1 Participants stand a chance to win 1 of 6 travel vouchers to the value of R70 000.00 each to one of 3 travel destinations – Thailand, Bali or Mauritius. The travel vouchers may only be redeemed at selected Computicket outlets, for one of the 3 holiday destinations.
 - 8.2 The prize is limited to the travel voucher, and no other costs will be covered by the Promoter. The winner will be liable for all other costs.
 - 8.3 Winners will be chosen via a random draw process by 1 January 2019 and will be announced by 15 January 2019. Verified winners will receive their prize by 31 January 2019.
 - 8.4 The Promoter/Promoter’s Agent will make 3 attempts within 3 days of the draw date, to contact the Winner on the telephone number on which they entered, failing which the Promoter will select an alternate winner via the same random draw process.

- 8.5 Winners must redeem the Prize within 12 months of being notified that they have won, failing which, the Winner will forfeit the Prize in its entirety, and shall have not claim against the Promote as a result thereof.
- 8.6 The Winner and any chosen travel partner/s must all be in possession of valid South African passports. Winner and travel partner/s passports must be valid for at least six months after the intended date of return to South Africa and have no less than 2 (two) full blank pages (available in the passport), in order to redeem the prize. Temporary passports will not be accepted.
- 8.7 No person may win more than one travel voucher in this Competition.
- 8.8 The prize cannot be transferred, exchanged for its cash value or for an alternate prize.
9. The Competition is in no way sponsored, endorsed or administered by, or associated with any third party, or any airways or accommodation providers.
10. The Winner, by accepting the Prize, confirms that the Winner and his/her travel partner are in good health and are fit to travel and participate in any activities which may form part of the Prize.
11. The Promoter reserves the right to audit the age and eligibility of the Participants and the validity of the entries, and may refuse to award the prize to the Winner if the Winner cannot provide proof of age to the satisfaction of the Promoter, or if the Promoter suspects any irregularities or fraudulent activities, including without limitation, through the manipulation of code or otherwise frequently falsifying data. In such event all Participants waive any rights which they may have against the Promoter or Shoprite Checkers (Pty) Ltd and acknowledge that they will have no recourse or claim of any nature whatsoever against the Promoter, Shoprite Checkers (Pty) Ltd, their agents, contractors and/or sponsors.
12. The Promoters shall not be responsible for any lost, damaged, delayed, incorrect or incomplete entries for any reason whatsoever. Proof of sending will not be accepted as proof of receipt.
13. The Promoters shall not be responsible for the failure of any technical element relating to this promotional competition that may result in an entry not being successfully submitted.
14. No applications from agents, third parties, organised groups or applications automatically generated by computer will be accepted. No incomplete or corrupted entries will be accepted. Entries will only be accepted if they comply with all entry instructions.
15. **NOTE:** Any attempt to use multiple accounts or other tactics to enter or vote more than the stated limit may result in disqualification and all associated entries and/or votes will be void. Entries or votes generated by script, macro, bot, commercial contest subscription, incentives or other means not sponsored by the Promoters, vote-swapping sites, voting software, entering service sites or any other automated means and entries

or votes by any means that subvert the entry/voting process or do not conform to the terms or spirit of these competition rules, will void the entry/votes and may disqualify the entrant.

There will be no compensation, in any form, (including, but not limited to monetary compensation) to any party, irrespective of the reason/s for inability of the Winner to travel on the date as arranged through Computicket. Time permitting, a substitute winner may, at the discretion of the Promoter, be chosen.
18. Promoter reserves the right to make media announcements and/or publications of the name and photographs of the Winner/s and their travel partner/s, provided that any Winner and/or travel partner/s may elect to expressly, in writing decline this.
19. Promoter reserves the right to use (repost) any content generated by Winner and traveling partner associated with the Competition across its platforms without compensation in any way.

Any personal data submitted by you will be used solely in accordance with current South African data protection legislation, the Consumer Protection Act and the Promoters' respective privacy policies. The Promoters may contact you for marketing purposes, on the basis that you will have the election to opt out at each interaction.

All Participants and Winners indemnify Promoter, Shoprite Checkers (Pty) Ltd, their associated companies (directors, officers and employees) and agents, against any / all claims for any loss or damages, whether direct, indirect, consequential or otherwise, arising from any cause whatsoever from their participation in any way howsoever in this Competition.
22. In the event that the prize is not available despite the Promoters' reasonable endeavours to procure the prize, the Promoters reserve the right to substitute prizes of equal value.
