

TERMS & CONDITIONS

1. The promoter is Unilever South Africa (Pty) Ltd ("the Promoter").
2. The promotional competition is open to all South African residents who are 18 years or older and are in possession of a valid identity document, except any director, member, partner, employee, agent or consultant of the Promoter, the marketing service providers or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members.
3. Any participant under the age of 18 years must be fully assisted by his/her guardian, who approves of and consents to the participant's participation in the competition and the participant's receipt/possession of the prize.
