

RULES

1. The promoters are Shoprite Checkers (Pty) Ltd and SABC (“the Promoters”).
2. This promotional competition is open to all South African residents who are 18 years or older, in possession of a valid identity document, except any director, member, partner, employee, agent or consultant of the Promoters, the marketing service providers or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members.
3. This promotional competition starts on 23 February 2019 and ends at midnight on 13 May 2019. The competition will run from each Saturday 18h00 to Monday 23h00. Any entries received after the closing times will not be considered.

 - 4.1 The presenter of each Premier League match, that is aired every Saturday on SABC 3 for the duration of the competition, will choose 3 plays from the game day for viewers to vote for.
 - 4.2 To enter, participants must SMS the keyword “Shoprite LiquorShop”, their name, identity number and their play of the day option.
