

SHOPRITE MONEY TRANSFER PROMOTION TERMS & CONDITIONS

1. The promoter is Shoprite Checkers (Pty) Ltd ("the Promoter").
2. The promotional competition is open to all South African residents who are in possession of a valid identity document, except any director, member, partner, employee, agent or consultant of the Promoter, the marketing service providers or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members.
3. Any participant under the age of 18 years must be fully assisted by his/her guardian, who approves of and consents to the participant's participation in the competition and the participant's receipt/possession of the prize.
4. This promotional competition is open from 15 April 2019 and ends at 12am (midnight) on 2 June 2019. Any entries received after the closing date will not be considered.
5. To enter, participants will be required to:
 - 5.1 Send money (Money Transfer) from Shoprite stores nationally
 - 5.2 Dial the USSD string *120*569*055*UNIQUECODE# to enter.
 - 5.3 Sms the word MONEY TRANSFERS, & the Competition Code on the Competition Till Slip to the competition sms line displayed on your till slip: *See till slip for details.*
 - 5.4 USSD 20 cents per 20 seconds
6. Participants must keep their till slip as proof of purchase.
7. Participants must enter in their correct contact details. If a winner's has given incorrect contact details, the Promoter reserves the right to select another winner in terms of the rules.
8. Participants may enter as many times as they wish provided that each entry is associated with a separate purchase and unique code.
