

**Shoprite Simba Back to School
TERMS & CONDITIONS**

1. The promoter is Shoprite Checkers (Pty) Ltd ("the Promoter").
2. Participation in the promotional competition constitutes acceptance of the promotional competition rules and participants agree to abide by the rules.
3. The promotional competition is open to all South African residents who are in possession of a valid identity document, except any director, member, partner, employee, agent or consultant of the Promoter, the marketing service providers or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members.
4. Any participant under the age of 18 (eighteen) years must be fully assisted by his/her guardian, who approves of and consents to the participant's participation in the competition and the participant's receipt/possession of the prize. The Promoter shall be entitled to request written consent.

 - *Participants may enter as many times as they wish provided that each entry is associated with a separate purchase. There will be 1 (one) prize per valid till slip.*
 - *Winners will be contacted via a call from Simba.*
