

## TERMS & CONDITIONS

1. The promoters are Shoprite Checkers (Pty) Ltd and Johnson & Johnson (Pty) Ltd ("the Promoters").
2. The promotional competition is open to all South African residents residing in the Northern and Gauteng regions and are in possession of a valid identity document, except any director, member, partner, employee, agent or consultant of the Promoters, the marketing service providers or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members.
