

## TERMS & CONDITIONS OF SHOPRITE BIG LOW PRICE CARNIVAL 2024 – GHANA

1. This promotional competition (“Big Low-Price Carnival Collab”) is conducted by Shoprite Ghana (Pty) Ltd (The Promoter). The promotional campaign is open to all Ghanaian residents residing in Ghana who are in possession of a valid identity document, except any director, member, partner, employee, agent or consultant of the Promoter, the marketing service providers or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members.
2. Any participant under the age of 18 years must be fully assisted by his/her guardian, who approves of and consents to the participant’s participation in the competition and the participant’s receipt/possession of the prize.
3. This promotion is open from 22 April 2024 at 08H00 and ends 09 June 2024 at 19H00.
4. To enter, participants will be required to:
  - 4.1 Purchase any 3 or more of the participating products at any Shoprite Store in Ghana to stand a chance to win 1 of 70 trolley dashes to a maximum value of 2,000 Cedi’s.
  - 4.2 Each qualifying transaction will receive a second till slip with a unique code to enter the competition on our WhatsApp number.
  - 4.3 Customers in their own discretion can use their mobile WhatsApp application to submit the unique code on their till slip to qualify for the draw.
  - 4.4 One unique code will qualify as one entry.
  - 4.5 4.5 All liquor, toiletries, butchery(meat) and Non-Foods are excluded (Toys, Small Appliances, Outdoor, and Kitchenware) from trolley dash.
5. Participants may enter as many times as they wish, provided each entry is associated with a separate purchase of the participating product.
6. A winner will be selected by means of random draw. All customers will be notified via their WhatsApp mobile number during the promotion should they be selected as a random winner. All winners will need to submit an ID Number as verification.
