

RULES

1. The promoters are Warshay Investments Pty (Ltd) ta KWV ("the Promoters").
2. This promotional competition is open to all South African residents who are 18 years or older, in possession of a valid identity document, except any director, member, partner, employee, agent or consultant of the Promoters, the marketing service providers or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members.
3. This promotional competition starts on 19 October 2020 and ends at 12am (midnight) on 20 December 2020. Any entries received after the closing date will not be considered.

 - 4.1. Buy 1 x 750ml Annabelle Cuvee Rose wine from CHECKERS OR SHOPRITE stores nationally as advertised in participating outlets.
 - 4.2. Dial USSD number, enter the last 4 digits of the barcode on the purchased product, select outlet where product was purchased (Shoprite or Checkers), select your age group and stand a chance to win.
