

## Braai Day LiquorShop Competition TERMS & CONDITIONS

1. The promoter is Shoprite Checkers (Pty) Ltd ("the Promoter").
2. The promotional competition is open to all South African residents over the age of 18 (Eighteen) and who are in possession of a valid identity document, passport or document of proof of South African residency. Any director, member, partner, employee, agent or consultant of the Promoter, the marketing service providers or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members may not enter or participate in the Competition and will automatically be disqualified upon entry.
3. This promotional competition is open from 23 August 2021 and ends at 12am (midnight) on 19 September 2021. Any entries received after the closing date will not be considered.
