

## SUPER CASH AND CARRY PHILIPPI PROMOTION TERMS & CONDITIONS

1. The promoter is Super Cash and Carry Philippi ("the Promoter").
2. The promotional competition is open to all South African residents who are 18 years or older and who are in possession of a valid South African identity document, passport or document of proof of South African residency. Any director, member, partner, employee, agent or consultant of the Promoter, the marketing service providers or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members may not enter or participate in this promotional competition and will automatically be disqualified upon entry.
