

Checkers Festive Competition Rules

Read these Competition rules carefully. These Competition rules (“rules”) explain your rights and duties in connection with this Competition. If you take part in this Competition and/or accept any prize, these rules will apply to you and you agree that the promoter(s) can assume that you have read and agreed to be legally bound by these Competition rules.

Promoter(s) Name(s):	This competition is run by FNB-eBucks, a business unit within First National Bank, a division of FirstRand Bank Limited (Registration No. 1929/001225/06 (“eBucks”). An Authorised Financial service and Registered Credit provider. Having its principal place of business at 10th Floor, FNB Place, First National Bank, Bank City, 30 Diagonal Street, Johannesburg, Gauteng, South Africa, 2000. The person responsible for conducting the promotional competition on behalf of eBucks is Bruce Gibbs a Partner Growth Manager at eBucks. In these rules we refer to the above promoter(s) as “the promoter(s)”, or “us” or “we”. We will refer to participants as “you”.
How to enter?	<ul style="list-style-type: none">To qualify for the competition, all you need to do is pay at Checkers (and Sixty60) with your qualifying FNB/RMB Private Banking card or eBucks, and swipe your Xtra Savings card, and stand the chance to win your share of 2 000 000 eBucks.

There will be 400 customers who will win R500 each (5000 eBucks) (a customer is limited to win once)The prize is not transferable to any person other than the drawn winner.The prize cannot be exchanged for cash or a different prize at the request of the winner.

Is there a limit on the number of times you can enter?	There is no limit on the number of entries. Every separate qualifying purchase from any Checkers Store (and Sixty60) using your FNB/RMB Private Bank or eBucks will count as an entry into the draw.

<p>Eligibility: Who qualifies to take part?</p>	<ul style="list-style-type: none"> • This Competition is open to any legal resident of the Republic of South Africa who is a natural person, 18 years of age or older at the time of entry and is an FNB/RMB Private Banking account holder, is a member of the eBucks Rewards Programme and has a Checkers Xtra savings card. Excluding the categories of people listed below who cannot take part.
<p>Who cannot take part?</p>	<p>The following persons may not take part in this Competition, will be disqualified if they do and will forfeit any prizes that may have been awarded to them:</p> <ol style="list-style-type: none"> a) Any employee of the promoter(s). b) Any director, member, partner, agent of, or consultant of the promoter(s). c) Any other person who directly or indirectly controls the promoter(s). d) Any supplier of goods and services in connection with this Competition. e) The spouse, life partner, siblings, children, or parents of any of the persons named in a, b, c, or d, above f) Persons whose accounts are not in "Good standing"- <i>An account that's in good standing means it isn't overdrawn, in arrears or in default; you haven't missed a premium and you aren't undergoing sequestration, business rescue, collection or liquidation proceedings (excluding debt review proceedings). <p>How will winner(s) be chosen?</p>	<p>A random draw will take place during the week commencing on 18 January 2021 to determine the winners. The entries drawn will be checked to establish whether they meet the Competition qualifying and eligibility criteria. The random draw will be overseen by the Legal, Risk & Compliance team at eBucks. The winners will be drawn from the transactional sales data for the Competition period. Should the Competition draw be postponed to another date for any reason whatsoever, the new date will be published on the FNB Website within four days of the original draw date. The random entry drawn will be checked to establish whether it meets the Competition qualifying criteria and if so that entry will be the prize winner, subject to us being able to contact such winner within 48 (forty-eight) hours of the draw taking place. <p>How will winner(s) names be announced?</p>	<p>The prize winner will be notified by eBucks via telephone in the week commencing 18 January 2021. If the prize winner cannot accept the prize for any reason whatsoever or cannot be reached through no fault of the Promoter after 2 working days, the prize will be awarded to additional participants drawn.</p>
<p>How will winners receive their prizes?</p>	<p>The winnings will be deposited into the winners' eBucks accounts. If the winner is an Easy account holder who is not a member of the eBucks Rewards Programme, an eBucks account will be opened for them.</p>
<p>Data Usage and Privacy Policy</p>	<p>Participants in the Competition understand and agree that in order to offer the Competition, we may collect and use personal information about participants. This personal information may include a participant's first name, last name, email address, mobile number and in certain instances your image. Personal data, which participants provide when they enter the Competition, may, subject to prevailing law, be used for future eBucks marketing activity, unless you notify eBucks that you wish to opt out of receiving such marketing communications. We will treat your information in total confidence and will not sell, share or rent this information to any other third parties. We reserve the right to amend, modify, cancel or withdraw any aspect of this Competition in our sole discretion at any time without notice or liability. We cannot guarantee the performance of any third party and shall not be liable for any act or default by a third party. Participants in this Competition agree that we will, subject to prevailing law, have no liability whatsoever for any injuries, losses, costs, damage or disappointment of any kind resulting in whole or in part, directly or indirectly from acceptance, misuse or use of a prize, or from participation in this Competition. The laws of the Republic of South Africa govern this Competition. If any provision or part of these Rules is deemed void or otherwise unenforceable in law then that provision or part shall be deemed excluded and the remainder of these Rules shall remain in force. IMPORTANT

- You agree to indemnify the promoters fully for any loss or damage the promoters may suffer because you breached the Competition rules.
