

**TERMS AND CONDITIONS OF THE CHECKERS CASHBACK GUARANTEE COMPETITION 2021 CONDUCTED BY SHOPRITE CHECKERS (PTY) LTD:**

All participants, by entering the Competition, agree to be bound by these terms and conditions:

1. Shoprite Checkers (Pty) Ltd ("the Promoter") is conducting this promotional competition ("the Competition").
2. The Competition is open to all South African residents who are in possession of a valid South African identity document, passport or document of proof of South African residency and who are registered Xtra Savings members with a valid Xtra Savings card. Any director, member, partner, employee, agent or consultant of the Promoter, the marketing service providers or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members may not enter or participate in the Competition and will automatically be disqualified upon entry.
3. Any participant under the age of 18 (Eighteen) years must be fully assisted by his/her guardian, who approves of and consents to the participant's participation in the competition and the participant's receipt/possession of a prize.

  - a. Be a registered Xtra Savings member with an active Xtra Savings card; and
  - b. Purchase any 3 (Three) participating items, which can be viewed by following the link provided at the end of these terms, from any Checkers or Checkers Hyper branded stores nationwide (excluding Checkers Liquorshop, Usave, Medirite, Money Market, Sixty60 and Computicket purchases); and
  - c. Swipe your Xtra Savings card to receive an automatic entry into the competition.
  - d. A participant will receive 1 (One) entry per qualifying basket, that has any 3 (Three) or more participating items.

*Therefore, as an example: on Monday a participant purchases 6 (Six) of the participating items, this will equate to 1 (One) entry for that specific transaction the number of participating items bought in excess of 3 (Three) will not accumulate more entries. If a customer goes back for a second shop on Tuesday, and purchases any 3 (Three) or more participating products, they will receive 1 (One) entry for that transaction.*

- a) Definition of an Xtra Savings customer - a customer who has joined the Xtra Savings Loyalty programme, registered with a full customer profile and swipes their card at the till. (Checkers and Checkers Hypers only)
- b) **TRANSACTIONS EXCLUDED FROM THE PROMOTION**  
Money Market, Computicket, MediRite, Usave, Sixty60 and Checkers Liquorshop transactions will not qualify.
- c) **CATEGORIES EXCLUDED FROM THE PROMOTION**
