

1. All persons ('the entrants') entering the Tall Horse Wines, on behalf of DGB (Proprietary) Limited, Competition ('the promotional competition') agree that the competition rules as set out in these terms and conditions are binding on them. 2. Important notice:

2.1 These terms and conditions and competition rules contain certain terms and conditions which appear in similar text style to this clause and which:

- o may limit the risk or liability of the promoter or a third party; and/or
- o may create risk or liability for the entrant; and/or
- o may compel the entrant to indemnify the promoter or a third party; and/or
- o serves as an acknowledgement, by the entrant, of a fact;
- o the entrant cannot be a juristic entity and must be an individual.

2.2 The entrant's attention is drawn to these terms and conditions because they are important and should be carefully noted.

6. Prize:

6.1 45 qualifying entrants will win their share of R200,000 cash (hereafter referred to as 'the Prize'), split as per below. To qualify for each of the below-mentioned phases, the purchase needs to be made and entry received within the specific timeframe detailed below.
