

NIVEA LOVE YOUR SKIN COMPETITION TERMS & CONDITIONS

1. The name of the competition is the Nivea Love Your Skin competition (“the Competition”).
2. The promoter of the Competition is Beiersdorf Consumer Products (Pty) Ltd (“the Promoter”).
3. The Competition is open to all South African residents who are in possession of a valid South African identity document, passport or document of proof of South African residency. Any director, member, partner, employee, agent or consultant of the Promoter, the marketing service providers or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members may not enter or participate in this Competition and will automatically be disqualified upon entry.
4. Any participant under the age of 18 (eighteen) years must be fully assisted by his/her guardian, who approves of and consents to the participant’s participation in the Competition and the participant’s receipt/possession of the prize.

 - 6.2 dial the USSD string *120*885*COMPETITIONCODE# to enter. *See till slip for details.*
 - 6.3 standard USSD rates apply 20 cents per 20 seconds
7. Participants must keep their till slip as proof of purchase.
8. Participants must enter in their correct contact details. If an eligible winner has provided incorrect contact details, the Promoter reserves the right to select another winner and these same terms and conditions shall apply.
