

## ANNABELLE SMEG FRIDGE TERMS AND CONDITIONS

1. The promoter is Warshay Investments Pty (Ltd) t/a KWV ("the Promoter").
2. This promotional competition is open to all South African residents who are over the age of 18 (Eighteen) years residing in South Africa and who are in possession of a valid identity document, passport or document of proof of South African residency.
