Huletts Christmas competition terms and conditions

- 1. The promoter is Tongaat Hulett Limited (Reg. No. 1892/000610/06) (in business rescue) ("the Promoter").
- 2. This promotional competition ("Competition") is open to all South African residents of 18 years and older, residing in South Africa, who are in possession of a valid identity document, passport or other documentary proof of South African residency.
