

## SAVLON PROMOTION TERMS & CONDITIONS

1. The promoter is Johnson & Johnson (Pty) Ltd ("the Promoter").
2. The promotional competition is open to all South African residents residing in Gauteng and the North West Province, who are in possession of a valid South African identity document, passport or document of proof of South African residency.
