

WELLINGTON'S SAUCES TERMS & CONDITIONS

1. The promoter is Pioneer Food Group Ltd – Grocery division - Wellington's Sauces ("the Promoter").
2. The promotional competition is open to all South African residents residing in South Africa and are in possession of a valid identity document, passport or document of proof of South African residency. Any director, member, partner, employee, agent or consultant of the Promoter, the marketing service providers or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members may not enter or participate in this promotional competition and will automatically be disqualified upon entry.
