

# Tru-Cape Freshmark Competition

**By entering the Tru-Cape Freshmark Competition, you automatically agree to the following Terms and Conditions set out below.**

1. This competition is open to all South African residents over the age of eighteen (18) years (any persons under the age of eighteen (18) must have their parent/guardian's permission before entering). All entrants under the age of 18 must be entered by a legal guardian or parent. However, the following persons are not eligible to enter: directors; members; business partners; employees; sales agents; advertising agency staff; advisors; or consultants of Tru-Cape, its associated companies, service providers and the immediate family members of these persons (including their spouses, life partners, parents, children, brothers and sisters), as well as the associated companies of entities or persons mentioned in this paragraph, including holding companies and subsidiaries, their employees, agents, subsidiaries and consultants.
2. Entries will be accepted from 30 August 2021 to midnight 13 September 2021. No entries received after midnight on 13 September 2021 will be considered.
3. Verified winners will be contacted by 30 September 2021.

8. Winners must provide a correct and useable address for courier to deliver prize. Should prize winners be uncontactable and therefore courier company cannot deliver the prize, within reason, the prize will be forfeited and a new winner will be chosen.
9. Any person that has won a main prize of any Tru-Cape competitions within the last two years may not enter the competition and be eligible for the prizes.
