

## BOKOMO WEET-BIX TERMS & CONDITIONS

1. The promoter is Bokomo Weet-Bix ("the Promoter").
2. The promotional competition is open to all South African residents who are residing in the Western Cape, Eastern Cape and Gauteng, and are in possession of a valid South African identity document, passport or document of proof of South African residency. Any director, member, partner, employee, agent or consultant of the Promoter, the marketing service providers or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members may not enter or participate in this promotional competition and will automatically be disqualified upon entry.

  - 6.4 Participants are also allowed to enter by Whatsapping their unique code on their till slip to the number as provided on the till slip.
