

WOODSTOCK GIN CO. COMPETITION TERMS & CONDITIONS

1. The promoter is Edward Snell & Co. (Pty) Ltd ("the Promoter").
2. The promotional competition is open to all South African residents who are 18 (Eighteen) years or older and who are in possession of a valid identity document, passport or document of proof of South African residency. Any director, member, partner, employee, agent or consultant of the Promoter, the marketing service providers or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members may not enter or participate in the competition and will automatically be disqualified upon entry.

5. Participants must keep their till slip as proof of purchase.
6. Participants must enter in their correct contact details. If a winner has given incorrect contact details, the Promoter reserves the right to select another winner in terms of the rules.
