

Terms and Conditions: Absa Rewards

These Terms and Conditions ("T&Cs") govern the participation of Absa Rewards Members ("Members") in earning and redeeming Rewards ("Real Cash Back") when shopping at participating Checkers and Shoprite retail outlets or via the Checkers Sixty60 and Shoprite Sixty60 applications.

By participating in the Absa Rewards program, Members confirm their acceptance of and agreement to comply with these T&Cs in addition to the Absa Rewards program terms, conditions and programme rules.

1. Rewards Offer

- 1.1. The launch offer will start on 16 August 2025 and end on 15 October 2025. Members who shop at the **Participating Stores** within the launch period can earn up to 60% real cash back, depending on their Rewards Tier.
- 1.2. Members who shop at the **Participating Stores** from 16 October 2025 onwards, can earn up to 30% real cash back, depending on their Rewards Tier.

2. Eligibility

To earn Real Cash Back, customers must:

- 2.1. Be registered Members of the Absa Rewards program.
- 2.2. Transact at one or more of the following **Participating Stores** (collectively referred to as "Participating Stores") where Members will earn Real Cash Back:

- 4.2. In the event of any such change or termination, the Shoprite Group will not be liable for any loss, damage, or inconvenience caused to Members.

- 5.1. The Shoprite Group shall not be held liable for:
 - 5.1.1. any direct or indirect loss or damage resulting from participation in the Absa Rewards program;
 - 5.1.2. unauthorised access to or fraudulent use of a Member's Absa Rewards account; and
 - 5.1.3. technical failures that prevent the accrual or redemption of Rewards.

6.1. These T&Cs are governed and interpreted in accordance with the laws of the Republic of South Africa.
