# CHECKERS LITTLE SHOP 5 PROMOTIONAL CAMPAIGN TERMS AND CONDITIONS

The Little Shop 5 Collectables are NOT TOYS, and they are not suitable for children younger than 4 years. They are small and could pose a choking hazard. Please refer to the safety warnings on the packaging. Adult supervision is required at all times for vulnerable persons and children of all ages, to prevent accidents and to ensure that the collectables are handled safely.

## 7. <u>Each participant may only receive a maximum of 10 Collectables per day.</u>

### For example:

- If a participant spends R2,000 in the same Qualifying Transaction, the participant may receive 10 Collectables.
- If a participant spends R5,000 in the same Qualifying Transaction, the participant may receive only 10 Collectables.

#### 8. Only from 10 - 12 October 2025, while Collectables stocks last:

- 8.1 Xtra Savings Plus members qualify for 2 Collectables per Qualifying Transaction; and
- 8.2 Each Xtra Savings Plus member may receive a maximum of 20 Collectables.

## 9. The Promoter cannot and does not guarantee:

- 9.1 that there will be enough Collectables to allocate until the end of the Campaign Period; or
- 9.2 that participants will receive all available Collectables.

- 10. Access to the Promotion does not guarantee stock of Collectables.
- 11. <u>If Collectables are out of stock at the time of a Qualifying Transaction, the Collectables that would have been allocated to the Qualifying Transaction will automatically be cancelled. Cancelled or out of stock Collectables:</u>
  - 11.1 cannot accrue;
  - 11.2 cannot be redeemed or claimed at another store; and
  - 11.3 will not be reallocated and cannot be claimed after the Qualifying Transaction.
- 12. The Promotion and Collectables are at all times subject to the stock availability and quantity limitations of Collectables as well as products.
- 13. Neither the Promoter nor its agents or suppliers will be liable for any direct or indirect losses, claims or damage ("Losses") in any way related to the Promotion or the Collectables.
- 14. Collectables are not transferrable, refundable or exchangeable. Unwanted Collectables must either be declined at point of sale, or placed into the dedicated recycling boxes located in the Promoter's stores.
- 15. Participants will not receive any discount, a replacement item or credit, if Collectables are out of stock.
- 16. The Promoter in its sole discretion is entitled to cancel a Collectable allocation, if the Promoter finds or suspects that:
  - 16.1 Fraud, dishonesty or cheating occurred, including without limitation, that a participant made use of the Promotion through the manipulation of code or falsifying of data; or
  - 16.2 Transactions were automatically generated; or
  - 16.3 Participants are making use of multiple Qualifying Transactions to obtain the Collectables, only to cancel those Qualifying Transactions or return the products purchased afterwards;
  - 16.4 If the Promoter's technology systems are affected by technical errors.
- 17. The Promoter is entitled to change or cancel the Promotion, or end the Campaign Period at any time without notice, if deemed necessary in its sole discretion. In the event of such change or cancellation, participants will have no recourse against the Promoter, its suppliers or agents.
- 18. Participants who access the Promotion agree to comply with these terms and conditions.
