## Deposit cash into your bank account at a Shoprite, Usave or Checkers till and stand a chance to win! Competition terms and conditions

- 1. The "Promoter" is Shoprite Checkers (Pty) Ltd.
- 2. This promotional competition ("Competition") is open to all legal residents of South Africa who are 18 years and older and are in possession of a valid identity document, passport, work permit or other documentary proof of South African residency.
