

TERMS & CONDITIONS

1. The promoter is SC Johnson (Pty) Ltd ("the Promoter").
2. The promotional competition is open to:
 - a. all South African residents in possession of a valid identity document,
 - b. has a copy of their Till Slip,
 - c. In selected Checkers Hyper / Checkers / Spar stores.
3.
