

SHOPRITE X UBER MOTO
Promotional Offer Terms and Conditions

1. The promoter is Uber Moto, South Africa ("the Promoter").
2. This promotional offer ("Offer") is open to all South African residents of 18 (eighteen) years and older, residing in South Africa, who are in possession of a valid identity document, passport, or other documentary proof of South African residency. Any director, member, partner, employee, agent or consultant of the Promoter or Shoprite Checkers (Pty) Ltd, the marketing service providers, suppliers, distributors, or any person who directly or indirectly controls or is controlled by these entities, including their spouses, life partners, business partners or immediate family members may not enter or participate in the Offer and will be disqualified from receiving the Offer.
