

Get 3 Months of Xtra Savings Plus for R99 Terms and Conditions

1. The promoter is Checkers SA. ("the Promoter").
2. This Campaign will start on 27 August 2025 ("start date") and end on 14 September 2025 ("closing date"). The period from the Campaign start date to closing date is referred to as the "Campaign Period." Any entries received after the closing date will not be considered.
3. To enter the Campaign, Customers identified and targeted through our direct communications are required to sign up for a R99 (ninety-nine rand) subscription. The next two months will be automatically discounted at 100%, after which the subscription will renew at R99 per month.
4. Customers will enjoy the benefits of being an Xtra Savings Plus member for 3 (three) months, whilst only paying for 1 (one) month.
5. Promotional codes will automatically be added to the members account and discounts applied will be shown on invoices after the second and third month.

7. By signing up, customers:

Customers will be given the opportunity to consent to further processing of their personal information;
 - 7.2 Where applicable, waive their moral rights and grant Shoprite Checkers (Pty) Ltd and the Promoter exclusive, unlimited, perpetual, and free of charge copyright and usage (in any territory where these entities trade), in all media forms of all material, text and intellectual property created and/or published/posted by the customers in the submission of their Campaign entry.
